

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MAY 2, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Stephen Crane of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of April 18, 2017, were approved and ordered filed on motion by Commissioner Rawhouser and seconded by Commissioner Bousman. The motion carried.

Butch Penton, Road and Bridge Superintendent, reported that new signs will cost approximately \$30 each, that the Industrial Site project has started, that gravel is being hauled and roads are being bladed.

Mark Eatinger, representing Rio Verde Engineering, reported that top soil is being removed on the Industrial Site project, that the chip seal proposals will be available for the next meeting, and that the FLAP grant application will be available for the next meeting to be submitted on May 19th.

Commissioner Noble discussed the Skyline Drive rocks and expressed his concern about the FLAP grant for the Upper Green River Lakes road and potential maintenance expense for the road if it is a gravel road instead of pavement.

Chairman Nelson discussed Forest Service Road 111 and the FLAP grant application proposed by the Town of Pinedale.

County Surveyor Skylar Wilson reported on the Afton Surveyor's Conference and discussed Forest land leases.

Ron Gordon, Waste Management, reported on water monitoring, permit from Wildlife Services for ravens, upcoming DEQ meeting in Lander, and funding from Lincoln County for LaBarge disposal.

It was moved by Commissioner Noble and seconded by Commissioner Bousman to issue a malt beverage permits to A Woman's Work for the Men's Cook off and Redneck Ball on May 13, 2017, at the Events Center. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to appoint Gary Neely to an unexpired term on the Museum Board. The motion carried.

It was moved by Commissioner Noble and seconded by Commissioner Bousman to appoint Kevin Schulz and Allison Long to unexpired terms on the Golf Committee. The motion carried.

It was moved by Commissioner Noble and seconded by Commissioner Rawhouser to accept a proposal from Barney Snyder to hay the Doyle property. The motion carried.

Jeff Goltz and Julie Maxam, representing the Children's Discovery Center, discussed a new property lease and a possible land purchase. The Board directed that a new lease be drafted.

Andy Currah, Julie Kraft, and Audra Rouge, representing the Weed and Pest District, presented a program overview for the Board.

Old Business. Commissioner Rawhouser reported on the WCCA Elections and Land Use Committee, the Fairground activities, and the Forest Collaborative Meeting. Commissioner Noble reported on SERC and Forest Service. Commissioner Burnett reported on the Lincoln County landfill meeting, WCCA, and WYDOT Mule Deer migration meeting. Commissioner Bousman reported on the Forest Collaborative Meeting, and the NACO Leadership Fly in to Washington, DC to lobby for PILT and SRS funding. Chairman Nelson reported on SERC, donkey basketball, and discussed Property Tax Relief.

County Clerk Mary Lankford reported on a meeting with WYDOT officials about WyoLink.

Joe Sharkey and Rachel Grimes presented a progress report on the Broadband Assessment Project.

Andre' Irely, Maintenance Superintendent, reported on maintenance projects.

Todd Hurd, representing Forsgren and Associates, reported that one proposal had been received from Premier Site Development for the Rendezvous Pointe Addition for the amount of \$388,000. The Board directed Hurd to review the proposal before awarding the project. Hurd reported on the Pinedale Fire Hall roof and stucco.

Commissioner Rawhouser reported on lighting on the statue at the Visitors Center.
