

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JUNE 20, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Stephen Crane and Anthony Goulette of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding budget workshops of June 5, 7, and 8, and the regular meeting of June 6, 2017, were approved and ordered filed on motion by Commissioner Rawhouser and seconded by Commissioner Noble. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve and sign two contracts with the State of Wyoming, Department of Health for the Public Health Nursing services and the County Health Officer. The motion carried.

Ron Gordon, Waste Management, discussed scraper repairs and was referred to Road and Bridge. Gordon reported that baler repair can be done in-house. Trading a water truck for grader tires was discussed and determined that the disposition of the water truck needed to be advertised.

Old Business. Commissioner Rawhouser reported on touring County roads and discussed Forest Service cooperation. Commissioner Noble reported on meeting with Elaina Zempel about ENDOW, meeting with the Forest Service about the rocks on Skyline Drive, and the upcoming Silver Star meeting. Commissioner Burnett reported on meeting with the St. John's Hospital CEO with Chairman Nelson, and touring County roads. Commissioner Bousman reported that the Western Governors Association meeting is in Montana next week, that Rio Verde Engineering will be working on a rock management plan for Skyline Drive, and that he had received a complaint about the Forest Service concerning the New Fork Lakes Boys Scout Camp. Chairman Nelson reported that the ENDOW conference will be June 29 and 30 at the Lovatt Room.

The Board deferred awarding renewal scholarships to the next meeting on July 3rd.

Shad Cooper, County Fire Warden, presented his monthly report. Cooper discussed water training and controlled burn notifications.

Sheriff KC Lehr reported on the Prevention Conference and on Search and Rescue.

In accordance with the public notice published in the Pinedale Roundup on June 9 and 16, 2017, a public hearing was held for the transfer from the Pinedale Golf Club, Inc. and issuance of a Special Club liquor license to the Sublette County Golf Committee for the Rendezvous Meadows Golf Course located at 55 Club House Road. County Clerk Mary Lankford reported that the application was not complete. It was moved by Commissioner Noble and seconded by Commissioner Rawhouser to issue the liquor license contingent upon the completion of the application. The motion carried.

Commissioner Bousman assigned his Veterans Liaison position to Commissioner Rawhouser.

Billie Hamby, Sublette County Veterans Service Officer, introduced herself to the Board and reported on starting her new position. Weekly outreach in Big Piney will be 9 a.m. to 1 p.m. every Thursday. Other outreach opportunities were discussed.

Butch Penton, Road and Bridge Superintendent, discussed fencing replacement at Espenscheid's, the Skyline Drive rock management plan, and Corps of Engineer permits. Work has been delayed at Vickrey's, due to high water.

Penton, Mark Eatinger, representing Rio Verde Engineering, and Micah Leadford, representing CFL, reported on touring the Skyline Drive. It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to approve the Acceptance Letter for the Skyline Drive project. The motion carried.

Mike Jackson, representing Rio Verde Engineering, presented a proposal for asphalt repair at the Fairgrounds for \$9,420 and at the Marbleton Clinic for \$30,291 from Teletractors, Inc. It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve the proposal for the total of \$39,711. The motion carried, with the vote being: Nelson, Bousman, Burnett, and Rawhouser-aye, and Noble-abstained.

Jackson reported on issues with the Ehman Lane easement, which requires a letter to the BLM.

The Board adjourned the meeting at 11:50 a.m. It returned at 1 p.m. to continue to meet in a budget workshop for FY18 budget preparation.
