

**OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
JANUARY 16, 2018**

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Holly Dabb of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

Chairman Nelson requested a moment of silence, and God's speed for former Commissioner Bob Tanner, who recently passed away. He served from 1979 through 1982

The minutes of the preceding regular meeting of January 2, 2018, were approved and ordered filed on motion by Commissioner Burnett and seconded by Commissioner Rawhouser. The motion carried.

The official bonds were approved for Cat Urbigkit, Secretary/Treasurer for the Sublette County Predator Board, in the amount of \$1,000; and Tyler Bergien, Treasurer for the Boulder Lake Ranch Improvement and Service District, in the amount of \$5,000 were approved and ordered filed with the County Treasurer.

Butch Penton, Road & Bridge Superintendent, reported on meeting with the owners of the Little Jenny Ranch and their snow catchers, utility markings on County roads, and ice on roads. The Board decided to close the Merna North Beaver County Road No. 23-115 at Buck Baker's Corner until April 15<sup>th</sup>.

Mark Eatinger, representing Rio Verde Engineering, discussed a resolution regarding marking utility boxes.

Commissioner Noble inquired if there had been a meeting between R.S. Bennett Construction and the BLM.

Corky Stetson requested bike path snow removal. The Board denied the request and referred him to the Recreation Board.

Billy Pape, Waste Management Superintendent, reported on door repairs, power, baler operation, hauling tires, water sampling, and permit modifications.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to issue a catering permit to the Boulder Bar for a wedding on January 20, 2018 at the Boulder Community Center. The motion carried.

Rachel Weksler, new Public Defender, introduced herself to the Board, and reported that she is planning to office at the Summit Building. It was agreed that the current stipend of \$1,000 per month would continue to be satisfactory.

Shad Cooper, County Fire Warden, presented a year-end report on County fire activities, and reported that \$130,047 was generated by apparatus and \$259,670.00 was generated by local firefighters.

Commissioner Bousman reported on meeting with WYDOT Director Bill Panos regarding WyoLink, with County Fire Warden Shad Cooper and Sheriff KC Lehr. It was agreed that continued communication is important.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to adopt Resolution No. 18-100318N opposing the legalization of marijuana in Wyoming. The motion carried.

Andre' Irely, Maintenance Superintendent, reported on boiler repair, jail doors, and Fire Training Facility generator.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to approve the addition of a progressive disciplinary policy for all County employees to the Sublette County Employee Handbook. The motion carried.

It was moved by Commissioner Noble and seconded by Commissioner Burnett to approve the Memorandum of Understanding between Jackson Hole Community Counseling Center and the Title 25 Partners of Sublette County. The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Bousman to appoint Carmel Kail to a three-year term on the Historic Preservation Board. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to send a letter of support for High Country Behavioral Health to the Wyoming Department of Health. The motion carried.

Old Business. Commissioner Rawhouser discussed the Rural Health Care District meeting on Friday. Commissioner Noble reported the broadband proposals, and meeting with Lincoln and Sweetwater Counties on January 24th. Commissioner Burnett discussed the Marbleton Clinic remodel and Commissioners Corner. Commissioner Bousman reported on the Cheney WSA bill, and the receipt of funding from the Joint Chiefs for the Forest Collaborative. Chairman Nelson had nothing to report.
