

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
APRIL 17, 2018

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Mack Rawhouser, Holly Dabb of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of April 3, 2018, were approved and ordered filed on motion by Commissioner Noble and seconded by Commissioner Burnett. The motion carried.

Commissioner Bousman discussed Mathis Lane and the Boulder Travel Management Plan.

Mike Jackson, representing Rio Verde Engineering, reported on Schedule A funding and the roads have been designated for two years. Commissioner Bousman discussed infrastructure funds.

The Board discussed the LaBarge Creek survey and Barbero denial to allow access to survey.

Jackson discussed an asphalt repair at Rendezvous Meadows Golf Course. The Board expressed its concern about safety issues and approved obtaining estimates for the repair.

Billy Pape, Waste Management Superintendent, and Eric Sackett, Rio Verde Engineering, reported on the DEQ permit, and the Board approved free dump days for the Big Piney area on May 16-19, and in Pinedale on a date to be determined.

Sheriff KC Lehr reported on the Polaris Country event on April 12 and the number of occupants in Detention Center.

Shad Cooper, County Fire Warden, presented his monthly report and reported on two fires yesterday. It was moved by Commissioner Rawhouser and seconded by Commissioner Burnett to approve and sign the Annual Operating Plan. The motion carried.

Commissioner Bousman reported on meeting with Tony Young, Chief Information Officer, State Enterprise Technology Services.

Bill Kluck, representing EMS, was informed by the Board that EMS will be included to the new radio system at no cost. EMS will need to provide compatible radios, and negotiate a contract with Dave's Electronics for maintenance.

It was moved by Commissioner Noble and seconded by Commissioner Burnett to approve a contract for one year for \$112,587.00 for Unified Fire and Sheriff's Office maintenance, and for \$30,023.20 for the new radio system build out. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to approve the grant award extension to June 30, 2018 for the Homeland Security grant. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to sign the BLM application for a perpetual right of way for the Ground Water Monitoring Wells at the old Pinedale Landfill site. The motion carried.

The following abatement petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Southern California Public POW, \$24,058.94.

Old Business: Commissioner Rawhouser reported on the Polaris Country event at the Fairgrounds, NACO teleconference, and Denbury, USDA/Rural Health Care District, and BLM meetings. Commissioner Noble reported on the CTC contract, and the USDA/Rural Health Care District meeting. Commissioner Burnett reported that he will be participating in a conference call this week concerning the Prevention program. Commissioner Bousman reported on attending the Denbury Open House, discussed the Department of Interior reorganization. Chairman Nelson reported on actions relating to the chair.

Scott Scherbel, representing the Rural Health Care District, presented a request for the following:

1. Will the County deed the entire 5-acre property and all buildings, etc., that are on the property to the District as a donation to the hospital project?
2. If not willing to donate, will the County sell the entire property to the District? If so, what would the selling price be?

The Board denied the request to donate the Clinic property, but expressed its willingness to sell the property for a fair offer to the District. It was moved by Commissioner Bousman and seconded by Commissioner Noble to appraise the Pinedale Clinic property, including the Clinic, Ambulance Barn, and Public Health Office Building. The motion carried. The Board expressed its desire to move forward and to discuss the sale and purchase with the USDA and District as soon as possible. Chairman Nelson informed Scherbel that the Public Health Office Building currently houses three departments and will need to be housed, if the sale is completed.

Scherbel also asked if the County would provide emergency funding, if it is needed, to keep both of the existing clinics operating at their current level during the construction and initial operation of the hospital should the available revenue sources of the District become insufficient. Chairman Nelson informed Scherbel that property matter needs to be resolved before the County would commit emergency funding.

Representative Albert Sommers presented a Legislative update from the 2018 Session.

Maxine Leckie encouraged working together on the hospital funding issue.

It was moved by Commissioner Bousman and seconded by Commissioner Noble approve emergency watershed protection for the Steele property and the NRCS assurances related to real property acquisition. The motion carried.
