

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
AUGUST 7, 2018

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Holly Dabb of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the budget hearing on July 16, 2018, and the regular meeting on July 17, 2018, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Noble. The motion carried.

Dave Nemetz, Treasurer of the Hoback Ranches Service and Improvement District, discussed the County Road petition for Rim Road that he had submitted and informed the Board that the Forest Service will soon be issuing a 60 foot easement to the District for the road. Nemetz also discussed the amount of taxes paid by the District and the lack of services received by the District from the County. At the direction of the Board, County Clerk Mary Lankford reviewed the assessed value of the District and the taxes paid to the County General Fund and its entities. Aaron Seehafer, representing Rio Verde Engineering, reviewed the Class II Road project that improved Rim Road, and discussed the significant improvements that would be required for the road to meet First Class County Road standards. Surface width, snow removal, school children, and traffic counts were discussed. The Board advised Nemetz that the road would need to meet First Class County Road standards before it would be considered.

Don Kranendonk, District Ranger for the Forest Service, discussed using Schedule A funding to improve the Clark's Draw road for access to the Monument Ridge Fuels and Vegetation Reduction project. Kranendonk informed the Board that there is \$70,000 available and requested the Board to consider a 50/50 match. The Board discussed the use of the road for the project and for future recreation for the public. The Board directed Kranendonk to work with Road and Bridge to prepare a scope of work and develop an estimate for the project.

Kranendonk, also, discussed the Youth program, and inquired about county funding.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to adopt Resolution No. 18-100336N establishing a 20 mph speed limit for Front Street County Road No. 23-209. The motion carried.

Mike Jackson, representing Rio Verde Engineering, reported on the Willow Creek project, crushing, and the drainage project at Rendezvous Meadows.

Billy Pape, Assistant Road and Bridge Superintendent, reported that the BLM had approved the repairs to the road to the Kismet tower. The Board requested that Pape review the Half Moon Road wash out for a possible Schedule A project. It was reported that the quality of the gravel produced by Green River Rock is good.

Billy Pape, Waste Management Manager, reported on the DEQ meeting to review the County permit and the few technical issues that need to be included. Pape reported that chemicals have been properly disposed and that the new hours are working well. The hydrant at Recycling has been moved.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to set the following mill levies for FY19:

Sheriff Lehr reported that SAR had five missions recently, including two recoveries, two rescues and tower repair. Lehr expressed his appreciation for the SAR volunteers.

It was moved by Commissioner Burnett and seconded by Commission Noble to approve and sign the contract with the Town of Big Piney for Unified Fire. The motion carried.

County Clerk Mary Lankford discussed the platform upgrade provided by Civic Plus for the County’s website.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve and sign the contract with the Wyoming Department of Health for the Prevention program. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to authorize the Public Health Nurse to fill a vacancy for a nursing position. The motion carried.

Old Business. Commissioner Rawhouser reported that the County Fair was successful and discussed inviting Representative Cheney for the WPLI public meeting. Commissioner Noble on continued effort to secure letters of support for broadband and his attendance at a Forest Service meeting concerning New Fork and Silver Lake irrigation. Commissioner Burnett discussed the WPLI recommendation. Commissioner Bousman reported on the Upper Green River ROD, Middle Piney Dedication, and a meeting with Rob Hoelscher on White Pine. Chairman Nelson discussed the upcoming PILT Fly In and White House invitation to Wyoming Counties, which Commissioner Bousman will be attending as Past President of WIR.

In accordance with the public notice published in the Pinedale Roundup on August 3, 2018, public hearing was held for the following:

1. It was moved by Commissioner Noble and seconded by Commissioner Rawhouser to approve and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried, with the vote being: Bousman-aye, Burnett-aye, Noble-aye, Rawhouser and Nelson-nay, and the following resolution was adopted:

RESOLUTION NO. 18-100337N

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION TO APPROVE THE APPLICATION BY FISH CREEK, LLC, FOR A CONDITIONAL USE PERMIT TO ALLOW A PRIVATE LANDING STRIP IN AN A-1 DISTRICT BEING PIN#30142630001400.

2. Application by Josh Adams and William and Pricilla Mecham, requesting that the Fire Protection Requirements of a 10,000 gallon year round water source and hydrant be omitted as a requirement for their proposed 9 Lot Subdivision. The proposed subdivision would be located within the boundaries of the earlier developed Industrial Site, and within the Mecham Lot Divisions #1 and #2. After lengthy discussion about the need for water sources and their maintenance, it was moved by Commissioner Bousman and seconded by Commissioner Burnett to remand the variance request back to Planning and Zoning for reconsideration of their recommendation to deny the request. The applicants withdrew their application, and the motion died. It was

moved by Commissioner Noble and seconded by Commissioner Bousman to deny the variance request. The motion carried.

Rob Hoelscher, District Ranger for the Forest Service, discussed the Lummis Park land acquisition and requested a letter of support from the Board. The White Pine Tower, Skyline Rocks, and agency cooperation was discussed. The Board recommended that Hoelscher schedule a standing appointment to meet with it in the future. The FLAP application for funding the Green River Lakes road improvements, Schedule A, and the locked gate at Sandy Beach picnic area were discussed.

The following petition and affidavit of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: QEP Energy Company, \$51,204.52; QEP Energy Company, \$13,319.07; QEP Energy Company, \$1,693.18; SWEPI LP, \$11,187.59; SWEPI LP, \$4,750.42; and various adjustments, \$4,614.
