## **Fire Warden Annual Report**

January 1, 2015 – December 31, 2015

### **I. EMERGENCY INCIDENTS**

- Between January 1, 2015 – December 31, 2015, there were a total of 181 emergency responses:
  - Pinedale – 62
  - Big Piney/Marbleton – 38
  - Bondurant – 14
  - Boulder – 21
  - Daniel – 32
  - Kendall Valley – 14
- A total of 827.06 hours were served on scene at emergency incidents in 2015.
- Our average en-route time in 2015 was 8 minutes and 7 seconds.
- 2,469:20 hours were spent from dispatch time to clearing the scene.
- The average time on scene in 2015 was 92:58 minutes.

### **II. FIRE INVESTIGATIONS**

- There were (8) eight fire investigations between January 1, 2015 and December 31, 2015.

### **III. FIRE PREVENTION**

- **SMOKE DETECTOR PROGRAM**
  - 80 smoke detectors were installed throughout Sublette County in 2015.

### **IV. TRAINING**

- **FIRE TRAINING**
  - 57 State Issued Training Qualifications were issued in 2015.
  - 2,108 classes were attended, with a total of 7,887 training hours.

### **V. HEALTH & SAFETY**

- Created a Firefighter accountability program will start in January 2016.
- A health and safety SOP was drawn up; along with a MOU with Dr. Wallace to oversee the program.
- An emergency response SOP was written.
- A MOU with the SCRHCD was signed to allow firefighters to drive ambulances during critical incidents.

### **VI. VOLUNTEER HOURS IN 2015**

- The firefighters donated 2,021 volunteer hours throughout the County and community.

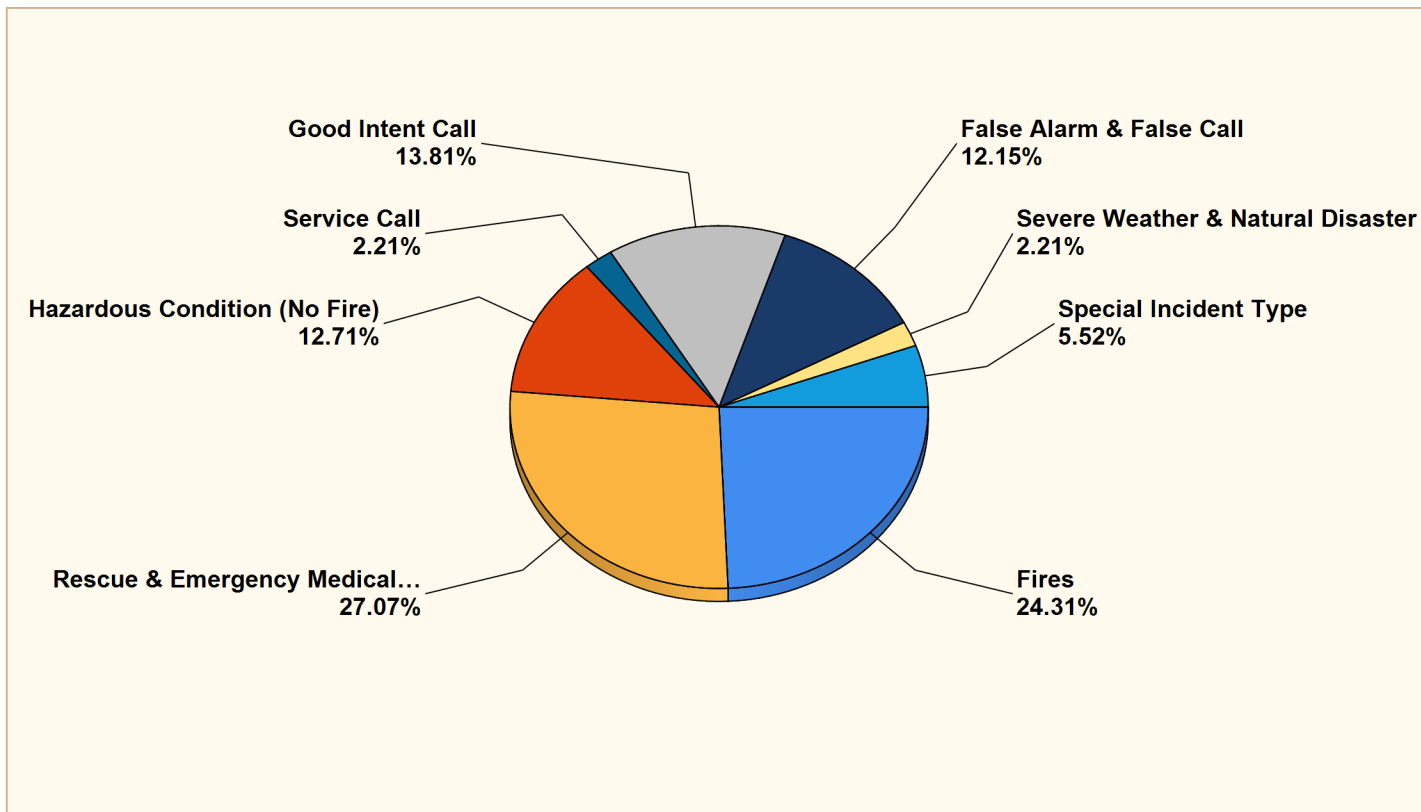

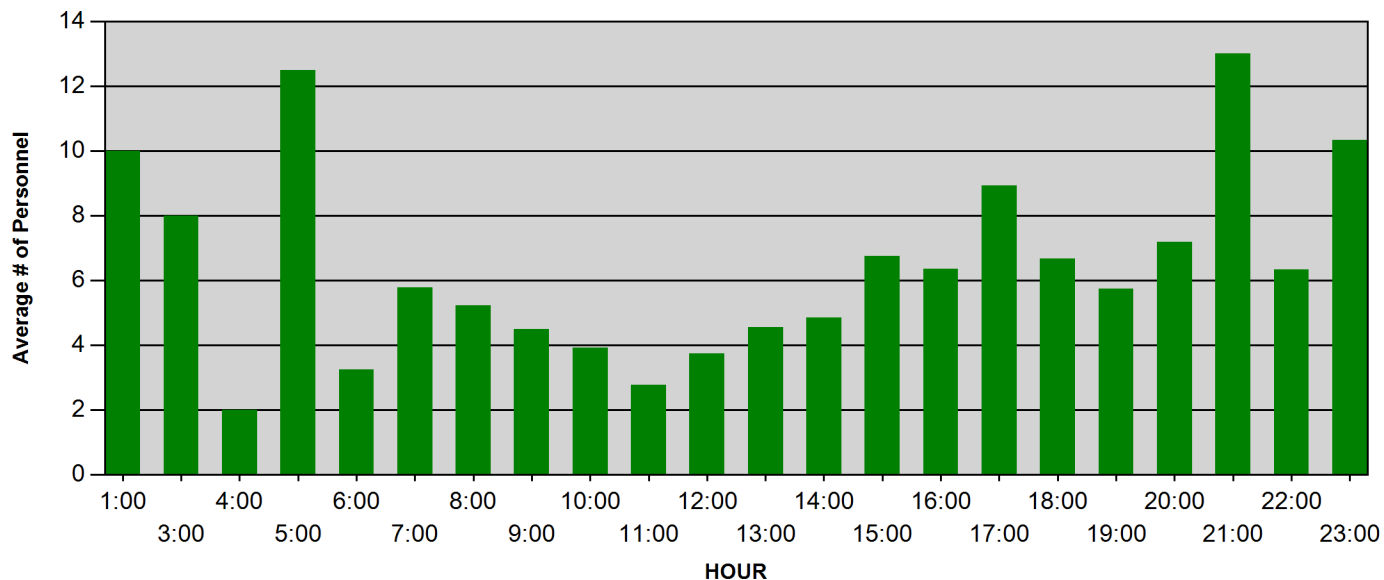
