

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

MAY 18, 2021

The Board of County Commissioners met in regular session in the Lovatt Room of the Sublette County Library on this date with Joel Bousman, Tom Noble, Doug Vickrey, Sam White, Dave Stephens, Clayton Melinkovich, Matt Gaffney, Brady Oltmans representing the Pinedale Roundup and Carrie Long, County Clerk, present.

Chairman Bousman led those present in the Pledge of Allegiance.

The Agenda was approved on motion by Commissioner Vickrey, seconded by Commissioner Stephens.

The minutes of the preceding meeting on May 4 were approved and ordered filed on motion by Commissioner Stephens, seconded by Commissioner Noble.

Billy Pape, Road & Bridge, met with the Board to update on activities. He also discussed possible rates for receiving trash from Kemmerer with direction from the Board to charge \$55 per ton.

Eric Sackett, Rio Verde Engineering, recommended accepting a bid from Intermountain Slurry Seal, Inc. in the amount of \$1,146,500.00 for the 2021 Chip Seal Project. Commissioner Noble made a motion to accept the recommendation, Commissioner White seconded the motion. Motion carried.

It was moved by Commissioner Stephens, seconded by Commissioner White to accept the bid from Searle Brothers Construction for Phase 2 of the Cottonwood Ryegrass Project in the amount of \$734,580.00. Motion carried with Commissioner Noble abstaining from the vote.

Commissioner Noble motioned to approve the two contracts presented by Janna Lee from Public Health, the first had tentative approval pending approval from the County Attorney's office regarding the County Health Officer, the second contract was for the Public Health Emergency Preparedness Contract. Commissioner Stephens seconded the motion. Motion carried.

Sam Bixler, Town of Marbleton, informed the Board the Town of Marbleton would accept the donation of the Marbleton Ball Fields if funding was made available to repair them. Monte Bolgiano stated the Recreation Board had set aside \$60,000 for the renovation of the ball fields. Chairman Bousman stated he would want the deed to specify the land is to be used as ball fields only, he instructed Melinkovich to contact Rio Verde to survey the land and proceed with the donation.

Crystal Thompson, Main Street Pinedale, requested use of the Courthouse lawn for Farmer's Market starting June 10 and for Rendezvous during July 7 – 12. She was instructed to contact Andre Irey, maintenance supervisor, for guidance and regulations.

Jennifer Matosky, Extension Office, requested the county take ownership and responsibility for vehicles donated to the 4H Foundation. Chairman Bousman stated the county did not wish to be responsible for 4H vehicles.

Bill Kluck, EMS, requested permission to paint a wall in the kitchen of the EMS building. He was instructed to proceed. He also requested \$25,000 of the \$50,000 received for Big Red be used to purchase and install a lift kit for one of the ambulances. He was instructed to make a budget request for the FY22 budget.

Matt Murdock, Mayor – Town of Pinedale, stated the Pinedale Airport will be renovating from June 15 – October 1 and should not disrupt traffic on the runway. He stated the runway will be closed for 10 weeks and that Emblem Aviation will move operations to the Big Piney / Marbleton airport during that time.

Todd Hurd, Forsgren & Associates, updated the Board on current projects.

It was moved by Commissioner White, seconded by Commissioner Noble to approve accounts payable in the amount of \$1,262,824.56. Motion carried.

The bond for Shannon McCormick, Clerk/Treasurer – Town of Marbleton, was approved on motion by Commissioner Noble, seconded by Commissioner White. Motion carried.

County Clerk, Carrie Long, requested direction from the Board on a scholarship deferral request from Addy Bennett. The deferral was granted.

In accordance with the public notice published in the Pinedale Roundup on May 7th & 14th, 2021, a public hearing was held for the renewal of the following liquor licenses and permits:

It was moved by Commissioner Noble, seconded by Commissioner White to approve the renewal applications for the following Retail Liquor Licenses: Green River Bar, Boulder Store & Pub, Elkhorn Trading Post, Lakeside Lodge, Daniel Junction, White Pine Ski Area & Resort, Kendall Valley Lodge, Half Moon Lake Lodge, The Place, Rim Station. The motion carried.

It was moved by Commissioner White, seconded by Commissioner Noble to approve the renewal applications for the following Restaurant Liquor Licenses: Fort William Recreation Area and Big Sandy Lodge. The motion carried.

It was moved by Commissioner Noble, seconded by Commissioner White to approve the renewal applications for a Limited Retail Liquor Licenses for Rendezvous Meadows Golf Course. The motion carried.

It was moved by Commissioner Noble, seconded by Commissioner White to approve the renewal application for a Satellite Manufacturer permit to Cowboy Country Distilling. Motion carried.

Chairman Bousman requested direction from the Board regarding using Richard Stem as a consultant for the Forest Collaborative. The Board supported having Stem consult on their behalf.

Shad Cooper, Fire Warden, requested authority to pre-pay the Wildland Fire apparatus rather than carry the budgeted amount into the fiscal year. He said he would hold back a portion of the payment pending completion and delivery of the apparatus. He was instructed to proceed.

The Board also gave Cooper latitude on decisions regarding the disposal of excess SCBA.

Emily Paravicini, County Treasurer, discussed with the Board, along with other entities the pros and cons of the Ad Valorem Exemption. It was moved by Commissioner Noble, seconded by Commissioner White to move forward with the application process. Motion carried 4 to 1 with Commissioner White voting nay.

The meeting adjourned at 3:10 p.m.
